

CHAPTER IV

CONCLUSION

There are two conclusions the researcher drew from the analysis, as following:

4.1. Veronica Koman's Activism in the West Papua Conflict

Veronica Koman's activism in the West Papua conflict was a response to the Aspirational Deprivation experienced by the OAP. Her activism was conducted through advocacy and dissemination of information in order to protect the human rights of OAP and raising awareness on the factual information of the conflict. Her publications were highly credible, resulting in her becoming an alternative source of information of the conflict particularly for foreign media who had limited access to the region.

4.2. Australia's Contradictory Foreign Policy and Domestic Demands in West Papua Conflict

Australia's commitment to Indonesia in Veronica Koman's case proceedings was attributed to Australia's perception of Indonesia as an important neighbour country and reluctance to trigger conflict potentially severing all relations with Indonesia, the seemingly united support of Indonesia's stable politics on the matter of West Papua's sovereignty, and the acknowledgment of Indonesia's legitimate claim over West Papua. This was conducted in consideration of Australia's own laws and procedures on the handling of Red Notice. However,

contradiction from Australia's domestic politics came mainly from the FWMP groups demanding not only intervention on human rights violations but also supporting the separation of West Papua. The cause was based on the limited information available regarding the conflict---whether from Indonesia limiting access or the lack of exposure towards Indonesia in Australia---and the numbers of participants in FWMP which represented not only political party but also students and academicians. With the pressure from domestic politics and the need to maintain a good relation with Indonesia, Australia chose to maintain silence and affirmation of Indonesia's sovereignty, therefore avoiding further potential tension from both sides.
