

BAB 4

KESIMPULAN

Penulisan penelitian ini bertujuan untuk meneliti alasan Korea Selatan menggagalkan *Comfort Women Agreement*. *Comfort Women Agreement* sendiri merupakan persetujuan rekonsiliasi yang dilakukan oleh Jepang dan Korea Selatan, dimana persetujuan rekonsiliasi tersebut dilaksanakan pada tahun 2015. Tujuan Jepang dan Korea Selatan melaksanakan persetujuan rekonsiliasi ini adalah untuk memperbaiki hubungan bilateralnya dengan cara menyelesaikan isu *comfort women*. Walaupun begitu pada tahun 2018, Presiden Korea Selatan, Moon Jae In, memutuskan untuk menggagalkan persetujuan rekonsiliasi ini. Hal tersebut pun memotivasi penulis untuk merumuskan pertanyaan penelitian pada penulisan ini, yaitu “Mengapa Korea Selatan memutuskan untuk menggagalkan ‘Comfort Women’ Agreement?”.

Penulis pun menemukan alasan mengapa Korea Selatan memutuskan untuk menggagalkan *Comfort Women Agreement*. Menurut analisis penulis, alasan pertama yang melatarbelakangi Korea Selatan untuk menggagalkan *comfort women agreement* sendiri terdapat pada kesalahan Korea Selatan *Comfort Women Agreement* sendiri dimulai dengan awal yang salah. Hal tersebut dapat dilihat dari bagaimana Park Geun Hye tidak melibatkan korban *comfort women* pada saat beliau menyetujui pelaksanaan *Comfort Women Agreement*, sehingga suara korban

comfort women pun tidak diwakilkan dalam persetujuan ini. Keterlibatan korban *comfort women* merupakan hal yang penting dalam proses rekonsiliasi.

Bagi masyarakat Korea Selatan khususnya korban *Comfort Women*, terdapat 4 hal yang harus dipenuhi oleh Jepang untuk tercapainya keadilan dan rekonsiliasi secara tuntas yaitu: Jepang memberikan permintaan maaf secara tulus dan formal kepada Korea Selatan dan juga korban *comfort women*, Jepang memberikan uang kompensasi kepada korban *comfort women* secara individu untuk mereparasi kerusakan yang timbul oleh isu *comfort women*, mengakui bahwa timbulnya isu *comfort women* dikarenakan perbuatan tentara militer Jepang, Jepang harus mengambil pertanggungjawaban hukum atas isu *comfort women*. Dari 4 poin ini, tidak ada satu poin pun yang dipenuhi oleh Jepang.

Pada saat berjalannya *Comfort Women Agreement*, Jepang menyatakan permintaan maaf nya kepada Korea Selatan yang diwakilkan oleh menteri luar negeri Jepang yang bernama Kishida Fumio. Permintaan maaf yang diwakilkan oleh Kishida Fumio sendiri merupakan permintaan yang tidak formal. Menurut korban *comfort women*, permintaan maaf yang formal adalah permintaan maaf yang dilakukan oleh Perdana Menteri Shinzo Abe kepada masing-masing korban secara tatap muka. 9 bulan dari sejak diselenggarakannya *Comfort Women Agreement*, masyarakat Korea Selatan menuntut Menteri Shinzo Abe untuk meminta maaf kepada masing-masing korban *comfort women*. Namun walaupun begitu Abe menolak permintaan masyarakat Korea Selatan tersebut. Peristiwa ini sendiri membuktikan bahwa Jepang tidak meminta maaf kepada Korea Selatan secara tulus. Ketidaktulusan Jepang dalam meminta maaf juga dapat dilihat dari

bagaimana Shinzo Abe menyangkal kesaksian para korban *comfort women* dengan cara menyatakan bahwa tidak adanya dokumen yang mencatat bahwa perempuan para *comfort women* diperlakukan secara koersif oleh tentara militer Jepang.

Shinzo Abe yang menyangkal kesaksian *comfort women* juga membuktikan bahwa Jepang tidak mengakui kebenaran sejarah isu *comfort women*. Hal ini merupakan salah satu faktor terbesar mengapa *Comfort Women Agreement* pada akhirnya digagalkan oleh Moon Jae In. Hal tersebut dikarenakan tidak hanya kebenaran sejarah merupakan permintaan dari korban *comfort women*, tetapi kebenaran sejarah merupakan hal terpenting yang harus dicapai dalam sebuah proses rekonsiliasi.

Terkait perihal pemberian uang kompensasi kepada masing-masing korban *comfort women*, Jepang menyatakan bahwa hal tersebut tidak dapat dipenuhi oleh Jepang karena pemberian uang kompensasi sebenarnya telah diselesaikan pada Perjanjian 1965. Namun alasan tersebut tidak dapat diterima oleh Korea Selatan dimana Perjanjian 1965 tidak sama sekali mendiskusikan isu *comfort women*. Jepang tidak hanya menolak untuk membayar uang kompensasi kepada masing-masing korban *comfort women*, tetapi Jepang juga membantah untuk mengambil pertanggungjawaban hukum walaupun hukum internasional telah membuktikan bahwa Jepang bersalah. Pengambilan pertanggungjawaban sendiri merupakan hal yang harus dicapai dalam sebuah rekonsiliasi, karena tidak hanya hal tersebut merupakan permintaan dari korban *comfort women* tetapi dengan

pengambilan tanggungjawab negara yang menjadi korban dapat merasa yakin bahwa hal yang serupa tidak terjadi kembali.

Perubahan struktur politik antar negara yang terlibat juga merupakan syarat untuk tercapainya sebuah rekonsiliasi. Namun dikarenakan tidak adanya permintaan maaf yang tulus dan formal, pengakuan kebenaran sejarah, dan pertanggungjawaban hukum yang diambil oleh Jepang, perubahan struktur politik ini tidak dapat dicapai. Hal ini lah yang menjadikan melalui *Comfort Women Agreement* digagalkan oleh presiden Moon Jae In.

Dari hasil analisis yang sudah ditemukan, terdapat 5 alasan mengapa Korea Selatan memutuskan untuk menggagalkan persetujuan rekonsiliasi *Comfort Women Agreement*. 5 Alasan tersebut tersebut adalah: (1) tidak dilibatkannya korban *comfort women* membuat mayoritas masyarakat Korea Selatan dan khususnya korban *comfort women* untuk tidak menentang pelaksanaan *Comfort Women Agreement*, (2) *Comfort Women Agreement* gagal untuk mendatangkan keadilan bagi para korban *comfort women*, (3) Jepang tidak mengakui kebenaran sejarah isu *comfort women* dimana hal ini merupakan salah satu hal terpenting untuk tercapainya sebuah rekonsiliasi antara Jepang dan Korea Selatan, (4) Jepang menolak untuk mengambil pertanggungjawaban hukum dimana hal ini juga merupakan salah satu hal terpenting untuk tercapainya rekonsiliasi Jepang dan Korea Selatan, (5) *Comfort Women Agreement* yang penuh dengan kekurangan dimana dimana banyak dari tuntutan korban *comfort women* yang tidak tercapai menyebabkan persetujuan rekonsiliasi tersebut tidak membantu Korea Selatan untuk mencapai restrukturisasi hubungan sosial dan politik.

Terdapat kekuatan dalam penulisan ini dimana penulis hendak menjelaskan kepada pembaca alasan mengapa Korea Selatan memutuskan untuk menggagalkan *Comfort Women Agreement*. Keputusan Korea Selatan untuk menggagalkan *Comfort Women Agreement* merupakan hal yang sulit untuk dimengerti, dimana Korea Selatan masih menolak untuk berekonsiliasi dengan Jepang walaupun Shinzo Abe telah memberikan permintaan maaf serta uang kompensasi kepada Korea Selatan. Walaupun begitu, terdapat kekurangan dari penelitian ini dimana penelitian ini hanya berfokus pada isu *comfort women* yang terjadi di Korea Selatan. Sedangkan isu *comfort women* sendiri tidak hanya terjadi pada wanita Korea Selatan saja tetapi juga kepada wanita di beberapa negara seperti di Indonesia, Vietnam, Taiwan, Singapura, Myanmar, Filipina, dan Thailand.

Dengan adanya kekurangan ini, penulis merekomendasikan bagi para peneliti untuk melakukan penelitiannya terhadap isu *comfort women* yang terjadi di negara yang belum dibahas dalam penulisan analisis ini. Tidak hanya itu saja tetapi penulis juga dapat melakukan penelitian lebih lanjut dan lebih dalam terhadap isu *comfort women* yang terjadi di Korea Selatan, dimana respon Korea Selatan terhadap isu *comfort women* dibawah kepemimpinan Yoon Suk Yeol dapat berubah. Hal tersebut dikarenakan pada tahun 2023, Presiden Yoon Suk Yeol banyak melakukan aksi untuk memperbaiki hubungan bilateral Korea Selatan dengan Jepang.
