### **CHAPTER V**

## CONCLUSION

### V.1 Conclusion

The sporadic events of armed conflict affecting the natural environment should be considered as war crimes. Specifically, the Kakhovka dam case had raised environmental issues due to its important role towards humans, industrial sites, energy providers, and also towards the environment. The destruction of the Kakhovka dam caused significant damage towards the environment with climate change, prolonged moisture to several species of pines that usually live in damp soils, ruining the spawning areas for fish, the spilling of oil that disturbs the ecological balance of the Black Sea, and more. Such widespread, long-term, and severe damage should be considered as war crimes and violates Article 8(2)(b)(iv) of the Rome Statute. Furthermore, these armed conflicts that impacted the environment happened after the enforcement of the Rome Statute where there is a Court with jurisdiction for such crimes. Therefore, the Kakhovka dam case should be brought to proceedings.

However, this did not happen due to the high threshold nature of Article 8(2)(b)(iv) specifically on its terms, "widespread, long-term, and severe." Those terms used by the Rome Statute were inspired by the AP I, therefore we should look into the *travaux preparatoires* of AP I. Pursuant to the commentaries of AP I, the threshold for widespread and severe is non-existent. The commentaries of AP I only provide the threshold for long-term which counts for decades. This standard is considered as vague and too high, leaving no cases brought to the ICC regarding environmental damages. A continuous use of those interpretations would lead to legal nullity where the regulation serves no purpose because even the greatest environmental damage does not meet the threshold of Article 35(3) and 55(1) of the AP I and Article 8(2)(b)(iv) of the Rome Statute.

Article 1 of the ENMOD used a similar term which is "widespread, long-lasting, or severe." Although Article 1 of the ENMOD has a non-cumulative nature compared to both the AP I and the Rome Statute which has a cumulative nature, the understanding of Article 1 of the ENMOD from A/31/27 UNGA Document provides a complete and clear threshold for those terms. Most importantly, the threshold for Article 1 of the ENMOD sets a lower standard than the one provided for the AP I. Therefore, the threshold for the term

"widespread, long-term, and severe" under Article 8(2)(b)(iv) of the Rome Statute should follow the threshold of Article 1 of the ENMOD.
