CLOSING

7.1 Conclusion

This chapter answers the research questions and objectives in CHAPTER I regarding the impact of learning public administration ethics through the film series *Dahmer-Monster: The Jeffrey Dahmer Story* on public administration students.

Based on the research results, it was found that students experienced the impact of narrative and empathy on learning public administration ethics through film series. Narratively, they succeeded in understanding ethical concepts such as impartiality, compliance, and integrity approach through the interaction of public administrators with the public in the film. Student also can analyze the storyline of the film to understand how the street level bureaucrat acted and made decision in their duties as a public-services. That shows that using films as a learning tool can effectively illustrate and present ethical concepts to public administration students

Apart from that, the impact of empathy is also experienced by students as evidenced by reflections about understanding feelings and dilemmas then describing the actions they choose when faced with the roles of characters in films. This shows that films can influence the development of student empathy in understanding other people's perspectives and experiences in the context of public administration ethics. As prospective

public administrators, students can also imagine what actions they should take when facing conflicts and dilemmas and solving social cases.

7.1 Suggestion

Based on research findings and conclusions regarding the impact of learning public administration ethics through film series, there are a suggestion for any universities that teaching public ethics for prospective public administrators. Other public administration study programs at other universities both nationally and internationally may use the film series as a learning model in the educational curriculum. Thus, the learning activities can broaden public administrators' understanding of ethical concepts, provide a solid foundation for putting theory into practice, and improve their ability to identify and resolve ethical dilemmas in the public administration environment.
