

BAB V

KESIMPULAN

Konflik yang terjadi di Semenanjung Krimea pada 2013-2015 menjadi permasalahan besar dalam penegakan hak sipil dan politik masyarakat Krimea, hal ini juga mempengaruhi kegagalan *International Covenant on Civil and Political Rights* sebagai rezim internasional dalam menghadapi kasus pelanggaran hak sipil dan politik yang terjadi di Semenanjung Krimea pada tahun 2013-2015. Kegagalan tersebut dipengaruhi oleh beberapa faktor jika mengacu pada konsep keberhasilan rezim internasional.

Faktor pertama yang mempengaruhi mempengaruhi kegagalan International Covenant on Civil and Political Rights sebagai rezim internasional dalam menghadapi kasus pelanggaran hak sipil dan politik yang terjadi di Semenanjung Krimea pada tahun 2013-2015 adalah adanya keterlibatan Rusia dalam konflik Semenanjung Krimea yang dilakukan untuk mempertahankan kepentingannya di wilayah tersebut, yang meliputi kepentingan ekonomi, politik dan militernya, karena Krimea secara geografis berada di wilayah yang strategis yang menghubungkan dengan benua Eropa serta berada di antara Laut Hitam dan Laut Azov yang secara umum menguntungkan bagi Rusia jika dapat mempertahankan bahkan merebut wilayah Krimea. Mengacu pada bab tiga penelitian ini, keterlibatan

Rusia dalam konflik Krimea memicu terjadinya pelanggaran hak sipil dan politik terhadap warga Krimea, terutama bagi mereka yang tidak berpihak pada Rusia.¹⁰⁷

Faktor penyebab kegagalan yang kedua yaitu memburuknya hubungan antara Rusia dengan Ukraina. Pasca pecahnya konflik di Semenanjung Krimea, , hubungan antara Rusia dan Ukraina semakin memanas, ditandai dengan terjadinya ancaman-ancaman antar kepala negara kedua negara hingga yang terburuk adalah pemutusan hubungan pada berbagai bidang (ekonomi,militer). Selain itu, hubungan buruk antara kedua negara memicu ketidakjelasan perundang-undangan yang diberlakukan di Krimea, karena Krimea yang secara hukum masih merupakan bagian dari Ukraina, masih menerapkan hukum Ukraina, begitu pula dengan Rusia, yang menggap pasca referendum wilayah tersebut menjadi milik Rusia walaupun tidak mendapat pengakuan. Ketiadaan hukum yang diberlakukan di Krimea rawan akan terjadinya pelanggaran hak sipil dan politik karena tidak ada yang mengatur secara jelas perilaku dan aktivitas masyarakat Krimea.¹⁰⁸

Faktor ketiga yang menyebabkan kegagalan rezim internasional ini yaitu perbedaan latar belakang masyarakat Krimea yang terdiri atas berbagai etnis mulai dari mayoritas etnis yaitu etnis Rusia yang pastinya pro-Rusia, hingga etnis pro-Ukraina seperti masyarakat Tatar Krimea menjadikan pandangan terhadap politik dan konflik berbeda-beda dan rawan terjadinya pemanfaatan kepentingan. Hadirnya etnis Rusia dimanfaatkan Rusia untuk melakukan referendum untuk

melepaskan diri dari Ukraina, dan memicu konflik dengan masyarakat etnis yang pro-Ukraina. Tentu, tidak adanya hubungan yang baik dalam suatu komunitas masyarakat, mendorong kegagalan ICCPR sebagai rezim internasional karena faktor tersebut membuat ICCPR tidak dapat diimplementasikan dengan baik di masyarakat.¹⁰⁹

Kegagalan ICCPR sebagai rezim internasional tentu menjadi persoalan besar dalam penegakan hak sipil dan politik di Semenanjung Krimea, hak yang tidak terpenuhi menjadi ancaman bagi masyarakat Krimea untuk bisa hidup secara wajar. ICCPR sebagai rezim internasional seharusnya bebas dari kepentingan aktor, agar ICCPR sebagai rezim internasional dapat menjadi pedoman tanpa harus dipengaruhi oleh pihak lain. ICCPR juga harus memperkuat perannya.
