

## BAB IV

### KESIMPULAN

Hasil analisa yang dilakukan menggunakan analisis wacana, yang melihat dari aspek artikel, pernyataan, dan foto. Berdasarkan tiga aspek yang disebutkan sebelumnya, dibatasi mulai dari *Inspire* edisi pertama, keempat, kedelapan dan kesepuluh. Dari penjabaran yang sudah dituliskan dalam bab analisis, penulis dapat melihat adanya bukti penggunaan teknik *repeated affirmation* oleh *Inspire*, dalam usahanya melakukan propaganda jihad di Barat dengan mengeluarkan konten utama berupa jihad adalah sesuatu hal yang baik. Jadi, penelitian ini dapat menjawab pertanyaan penelitian berupa, terdapat signifikansi antara konten propaganda majalah *online* dan peningkatan terorisme domestik.

Hal tersebut dapat dibuktikan dengan majalah *Inspire* merupakan majalah *online* yang memunculkan adanya terorisme domestik dari kejadian di *Boston Marathon* pada 15 April 2013. *Repeated affirmation* terbukti dilakukan para editor *Inspire*, dilakukan dengan mengulang melalui artikel, pernyataan, dan foto yang disajikan. Hal tersebut dilakukan sebagai bentuk menggiring pemikiran para simpatisan bahwa jihad adalah sesuatu yang wajib dan salah satu cara untuk ditempatkan sebagai seseorang yang berjasa dalam membela agama Islam. Propaganda yang dilakukan *Inspire* sukses, dibuktikan dengan pelaku *Boston Marathon Bombing* yang mengkonsumsi *Inspire* sebagai cara menghubungkan perspektif mereka dengan Al-Qaeda untuk membela apa yang telah Amerika Serikat lakukan di Afghanistan dan Irak.

Dampak positif dari globalisasi hadirnya kecanggihan teknologi, berupa internet, namun terdapat celah yang dimanfaatkan oleh organisasi teroris. Dari kejadian *Boston Marathon Bombing*, dapat kita simpulkan bahwa keamanan dan pertahanan sebuah negara dapat diserang dari dalam negara itu sendiri. Warga negara yang perlahan menjadi simpatisan akan mengancam keamanan dan pertahanan negara, tempat tinggal mereka. Terorisme domestik merupakan ancaman yang masih baru tetapi perlu diperhatikan keberadaannya, siapapun dan dimanapun dapat terkena dampak dari radikalisasi melalui bentuk apapun, terutama dalam penelitian ini adalah bentuk digital. Oleh karena itu, masyarakat pengguna teknologi komunikasi dan informasi harus semakin sadar akan perkembangan dunia dan mengantisipasi perubahan-perubahan dan ancaman tersebut bagi diri, lingkungan keluarga, lingkungan sosial, maupun kehidupan bernegara.
